SECTION I - INVITATION FOR TENDERS Date:2019
TENDER FOR PROVISION OF MEDICAL INSURANCE

- 1.1 The Kenya Rural Roads Authority (KeRRA) invites sealed tenders from eligible bidders for provision of Medical Insurance Cover for a period of 24 months commencing from August 2019.
- 1.2 A complete set of tender documents may be downloaded by interested Candidates from our website www.kerra.go.ke and/or IFMIS Suppliers Portal: www.supplier.treasury.go.ke free of charge.

The mandatory requirements are as follows:-

Should provide proof of compliance with thresholds specified in the document covering the following;

- (i) Certificate of Incorporation
- (ii) Statement of accounts for the last three (3) years
- (iii) Must have a Valid Tax Compliance Certificate
- (iv) All tenders must be accompanied by a tender security of Ksh. 200, 000.00 (Kenya Shillings Two Hundred Thousand only) in form of Bank Guarantee in the format provided in the tender document valid for at least 150 days from the closing day of the tenders.

- 1.3 Completed tender documents are to be enclosed in plain sealed envelopes marked with tender reference number and be deposited in the Tender Box on the 6th Floor, Blue Shield towers, Hospital Road-Upper hill, Nairobi or be addressed to:

- 1.4 Prices quoted should be net inclusive of all taxes, and delivery costs, must be in Kenya Shillings and shall remain valid for (120) days from the closing date of the tender. Completed tender documents are to be enclosed in plain, separate, sealed envelopes, marked with the tender number and name and be deposited in the Tender Box at Blue Shield Towers, 6th Floor, Hospital Road, Nairobi, so as to be received on or before **23rd July, 2019 at 11.00AM**
- 1.5 Tenders will be opened immediately thereafter in the presence of the bidders' representatives who choose to attend at the Boardroom, Blue Shield Towers, 6th Floor, Hospital Road, Nairobi.

SECTION II - INSTRUCTIONS TO TENDERERS

2.1. Eligible Tenderers

- 2.1.1 This Invitation for Tenders is open to all tenderers eligible as described in the Appendix to Instructions to Tenderers. Successful tenderers shall provide the services for the stipulated duration from the date of commencement (hereinafter referred to as the term) specified in the tender documents.
- 2.1.2 KeRRA's employees, committee members, board members and their relatives (spouse and children) are not eligible to participate in the tender unless where specially allowed under Section 66 of the Public Procurement and Asset Disposal Act 2015
- 2.1.3 Tenderers shall provide the qualification information statement that the tenderer (including all members of a joint venture and subservice providers) is not associated, or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by KeRRA to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the services under this Invitation for tenders.
- 2.1.4 Tenderers involved in the corrupt or fraudulent practices or debarred from participating in public procurement shall not be eligible.

2.2 Cost of Tendering

- 2.2.1 The Tenderer shall bear all costs associated with the preparation and submission of its tender, and KeRRA, will in no case be responsible or liable for those costs. Regardless of the conduct or outcome of the tendering process

2.3 Contents of Tender Document

- 2.3.1 The tender documents comprise the documents listed below and addenda issued in accordance with clause 2.5 of these instructions to tenderers.
- (i) Instructions to Tenderers
 - (ii) General Conditions of Contract
 - (iii) Special Conditions of Contract
 - (iv) Schedule of Requirements
 - (v) Details of Insurance Cover
 - (vi) Form of Tender
 - (vii) Price Schedules
 - (viii) Contract Form
 - (ix) Confidential Business Questionnaire Form
 - (x) Tender security Form
 - (xi) Performance Security Form
 - (xii) Insurance Company's Authorization Form
 - (xiii) Declaration Form
 - (xiv) Request for Review Form

- 232 The Tenderer is expected to examine all instructions, forms, terms and specification in the tender documents. Failure to furnish all information required by the tender documents or to submit a tender not substantially responsive to the tender documents in every respect will be at the tenderers risk and may result in the rejection of its tender.

2.4 Clarification of Tender Documents

- 241 A Bidder making inquiries of the tender documents may notify KeRRA by post or by email at KeRRA's address indicated in the Invitation for tenders. KeRRA will respond in writing to any request for clarification of the tender documents, which it receives not later than **seven (7)** days prior to the deadline for the submission of the tenders, prescribed by KeRRA. Written copies of the procuring entities response (including an explanation of the query but without identifying the source of inquiry) will be sent to all bidders who have received the tender documents.

- 242 KeRRA shall reply to any clarifications sought by the tenderer within 3 days of receiving the request to enable the tenderer to make timely submission of its tender.

- 243 Preference where allowed in the evaluation of tenders shall not exceed 15%.

2.5 Amendment of Tender Documents

- 251 At any time prior to the deadline for submission of tenders, KeRRA, for any reason, whether at its own initiative or in response to a clarification requested by a prospective tenderer, may modify the tender documents by issuing an addendum.

- 252 All prospective tenderers who have obtained the tender documents will be notified of the amendment by post, fax or email and such amendment will be binding on them.

- 253 In order to allow prospective tenderers reasonable time in which to take the amendment into account in preparing their tenders, KeRRA, at its discretion, may extend the deadline for the submission of tenders.

2.6 Language of Tenders

- 261 The tender prepared by the tenderer, as well as all correspondence and documents relating to the tender exchanged by the tenderer and KeRRA, shall be written in English language. Any printed literature furnished by the tenderer may be written in another language provided they are accompanied by an accurate English translation of the relevant passages in which case, for purposes of interpretation of the tender, the English translation shall govern.

2.7 Documents Comprising the Tender

- 2.7.1 The tender prepared by the tenderer shall comprise the following components:
- (a) A Tender Form and a Price Schedule completed in accordance with paragraph 2.8, 2.9 and 2.10 below

- (b) Documentary evidence established in accordance with paragraph 2.1.2 that the tenderer is eligible to tender and is qualified to perform the contract if its tender is accepted;
- (c) Tender security furnished in accordance with paragraph 2.12 (if applicable)
- (d) Declaration Form.

2.8. Form of Tender

- 2.8.1 The tenderer shall complete the Tender Form and the Price Schedule furnished in the tender documents, indicating the services to be provided.

2.9. Tender Prices

- 2.9.1 The tenderer shall indicate on the form of tender and the appropriate Price Schedule the unit prices and total tender price of the services it proposes to provide under the contract.
- 2.9.2 Prices indicated on the Price Schedule shall be the cost of the services quoted including all **customs duties** and **VAT** and other **taxes payable**.
- 2.9.3 Prices quoted by the tenderer shall remain fixed during the Term of the contract unless otherwise agreed by the parties. A tender submitted with an adjustable price quotation will be treated as non-responsive and will be rejected, pursuant to paragraph 2.20.5

2.10. Tender Currencies

- 2.10.1 Prices shall be quoted in Kenya Shillings

2.11. Tenderers Eligibility and Qualifications

- 2.11.1 Pursuant to paragraph 2.1 the tenderer shall furnish, as part of its tender, documents establishing the tenderers eligibility to tender and its qualifications to perform the contract if it's tender is accepted.
- 2.11.2 The documentary evidence of the tenderer's qualifications to perform the contract if its tender is accepted shall establish to KeRRA's satisfaction that the tenderer has the financial and technical capability necessary to perform the contract.

2.12. Tender Security

- 2.12.1 The tenderer shall furnish, as part of its tender, a tender security for the amount and form specified in the Appendix to Instructions to Tenderers.
- 2.12.2 The tender security shall not exceed 2 per cent of the tender price.
- 2.12.3 The tender security is required to protect KeRRA against the risk of Tenderer's conduct which would warrant the security's forfeiture, pursuant to paragraph 2.12.5

- 2.12.4 The tender security shall be denominated in Kenya Shillings or in another freely convertible currency, and shall be in the form
- a) Cash.
 - b) A bank guarantee.
 - c) Such insurance guarantee approved by the Authority.
 - d) Letter of credit.
- 2.12.4.1 Any tender not secured in accordance with paragraph 2.12.1. and 2.12.3 shall be rejected by KeRRA as non-responsive, pursuant to paragraph 2.20.5
- 2.12.4.2 Unsuccessful Tenderer's tender security will be discharged or returned as promptly as possible but not later than thirty (30) days after the expiration of the period of tender validity
- 2.12.4.3 The successful Tenderer's tender security will be discharged upon the tenderer signing the contract, pursuant to paragraph 2.29, and furnishing the performance security, pursuant to paragraph 2.30
- 2.12.5 The tender security may be forfeited:
- (a) If a tenderer withdraws its tender during the period of tender validity.
 - (b) in the case of a successful tenderer, if the tenderer fails:
 - (i) to sign the contract in accordance with paragraph 2.29 or
 - (ii) to furnish performance security in accordance with paragraph 2.30.
 - (c) If the tenderer rejects correction of an arithmetic error in the tender.

2.13. Validity of Tenders

- 2.13.1.1 Tenders shall remain valid for 120 days after date of tender opening pursuant to paragraph 2.18. A tender valid for a shorter period shall be rejected by KeRRA as non-responsive.
- 2.13.1.2 In exceptional circumstances, KeRRA may solicit the Tenderer's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The tender security provided under paragraph 2.12 shall also be suitably extended. A tenderer granting the request will not be required nor permitted to modify its tender.

2.14. Format and Signing of Tenders

- 2.14.1 The tenderer shall prepare **one (1)** original and **one (1)** copy of the tender, clearly marking each "**ORIGINAL TENDER**" and "**COPY OF TENDER**," as appropriate. In the event of any discrepancy between them, the original shall govern.
- 2.14.2 The original and all copies of the tender shall be typed or written in indelible ink and shall be signed by the tenderer or a person or persons duly authorized to bind the

tenderer to the contract. All pages of the tender, except for un-amended printed literature, shall be initialled by the person or persons signing the tender.

- 2.14.3 The tender shall have no interlineations, erasures, or overwriting except as necessary to correct errors made by the tenderer, in which case such corrections shall be initialled by the person or persons signing the tender.

2.15 Sealing and Marking of Tenders

- 2.15.1 The Original and all copies of the Technical Proposal shall be placed in a **clearly sealed and separate envelope** marked **‘Technical Proposal’** and the original and copies of the **Financial Proposal** shall be placed in another **sealed separate envelope** clearly marked **‘Financial Proposal’** bearing the name and address of the tenderer and warning **‘DO NOT OPEN WITH THE TECHNICAL PROPOSAL’**. Both envelopes shall be placed into one envelope and sealed. This outer envelope shall be clearly marked **‘Tender for provision of Medical Insurance Cover’**.
- 2.15.2 The inner and outer envelopes shall:
- (a) Be addressed to KeRRA at the address given in the Invitation to Tender i.e. **The Director General, Kenya Rural Roads Authority, P. O. Box 48151 – 00100, Nairobi.**
- 2.15.3 Bear tender number and name in the invitation to tender and the words, **“DO NOT OPEN BEFORE” 23rd July, 2019 at 11.00AM**. The inner envelopes shall also indicate the name and address of the tenderer to enable the tender to be returned unopened in case it is declared “late”.
- 2.15.4 If the outer envelope is not sealed and marked as required by paragraph 2.15.2, KeRRA will assume no responsibility for the tender’s misplacement or premature opening.

2.16. Deadline for Submission of Tenders

- 2.16.1 Tenders must be received by KeRRA at the address specified under paragraph 2.15.2 not later than **23rd July, 2019 at 11.00AM**
- 2.16.2 KeRRA may, at its discretion, extend this deadline for the submission of tenders by amending the tender documents in accordance with paragraph 2.5.3 in which case all rights and obligations of KeRRA and bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
- 2.16.3 Bulky tenders which will not fit the tender box shall be received by KeRRA as provided for in the Appendix to Instructions to Tenderers.

2.17. Modification and Withdrawal of Tenders

- 2.17.1 The tenderer may modify or withdraw its tender after the tender's submission, provided that written notice of the modification, including substitution or withdrawal of the tenders, is received by KeRRA prior to the deadline prescribed for submission of tenders.
- 2.17.2 The tenderer's modification or withdrawal notice shall be prepared, sealed, marked and dispatched in accordance with the provisions of paragraph 2.15. A withdrawal notice may also be sent by fax or email but followed by a signed confirmation copy, postmarked not later than the deadline for submission of tenders.
- 2.17.3 No tender may be modified after the deadline for submission of tenders.
- 2.17.4 No tender may be withdrawn in the interval between the deadline for submission of tenders and the expiration of the period of tender validity. Withdrawal of a tender during this interval may result in the Tenderer's forfeiture of its tender security, pursuant to paragraph 2.12.7.

2.18. Opening of Tenders

- 2.18.1 KeRRA will open all tenders in the presence of tenderers' representatives who choose to attend, on **23rd July, 2019 at 11.00AM** and in the location specified in the invitation for tenders. The tenderers' representatives who are present shall sign a register evidencing their attendance
- 2.18.2 The tenderers' names, tender modifications or withdrawals, tender prices, discounts, and the presence or absence of requisite tender security and such other details as KeRRA, at its discretion, may consider appropriate, will be announced at the opening.
- 2.18.3 KeRRA will prepare minutes of the tender opening, which will be submitted to tenderers that signed the tender opening register and will have made the request.

2.19 Clarification of Tenders

- 2.19.1 To assist in the examination, evaluation and comparison of tenders KeRRA may, at its discretion, ask the tenderer for a clarification of its tender. The request for clarification and the response shall be in writing, and no change in the prices or substance of the tender shall be sought, offered, or permitted.
- 2.19.2 Any effort by the tenderer to influence KeRRA in KeRRA's tender evaluation, tender comparison or contract award decisions may result in the rejection of the tenderers' tender.

2.20 Preliminary Examination and Responsiveness

- 2.20.1 KeRRA will determine to its satisfaction whether the tenderer that is selected as having submitted the highest combined score is qualified to perform the contract satisfactorily.

- 2.20.2 Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail, and the total price shall be corrected. If the bidder does not accept the correction of the errors, its tender will be rejected, and its tender security forfeited. If there is a discrepancy between words and figures, the amount in words will prevail
- 2.20.3 KeRRA may waive any minor informality or non-conformity or irregularity in a tender which does not constitute a material deviation provided such waiver does not prejudice or affect the relative ranking of any tenderer.
- 2.20.4 Prior to the detailed evaluation, pursuant to paragraph 2.20, KeRRA will determine the substantial responsiveness of each tender to the tender documents. For purposes of these paragraphs, a substantially responsive tender is one which conforms to all the terms and conditions of the tender documents without material deviations. KeRRA's determination of a tender's responsiveness is to be based on the contents of the tender itself without recourse to extrinsic evidence.
- 2.20.5 If a tender is not substantially responsive, it will be rejected by KeRRA and may not subsequently be made responsive by the tenderer by correction of the non conformity.

2.21. Conversion to single currency

- 2.21.1 Where other currencies are used, KeRRA will convert those currencies to Kenya Shillings using the selling exchange rate on the date of tender closing provided by the Central Bank of Kenya.

2.22. Evaluation and Comparison of Tenders

- 2.22.1 KeRRA will evaluate and compare the tenders which have been determined to be substantially responsive, pursuant to paragraph 2.20
- 2.22.2 KeRRA's evaluation of a tender will take into account, in addition to the tender price, the following factors, in the manner and to the extent indicated in paragraph 2.22.3.
- (a) Operational plan proposed in the tender;
 - (b) Deviations in payment schedule from that specified in the Special Conditions of Contract
- 2.22.3 Pursuant to paragraph 2.22.2, the following evaluation methods will be applied.
- (a) Operational Plan
 - (i) KeRRA requires that the services under the Invitation for Tenders shall be performed at the time specified in the Schedule of Requirements.

Tenderers offering to perform longer than KeRRA have required delivery time will be treated as non-responsive and rejected.

(b) Deviation in payment schedule

(i) Tenderers shall state their tender price for the payment on schedule outlined in the special conditions of contract.

Tenders will be evaluated on the basis of this base price.

Tenderers are, however, permitted to state an alternative payment schedule and indicate the reduction in tender price they wish to offer for such alternative payment schedule. KeRRA may consider the alternative payment schedule offered by the selected tenderer.

2.22.4 The tender evaluation committee shall evaluate the tender within 30 days from the date of opening the tender.

2.23. Contacting KeRRA

2.23.1 Subject to paragraph 2.19 no tenderer shall contact KeRRA on any matter relating to its tender, from the time of the tender opening to the time the contract is awarded.

2.23.2 Any effort by a tenderer to influence KeRRA in its decisions on tender evaluation, tender comparison, or contract award may result in the rejection of the Tenderers' tender.

2.24 Post-qualification

2.24.1 The Procuring entity will verify and determine to its satisfaction whether the tenderer that is selected as having submitted the highest combined score responsive tender is qualified to perform the contract satisfactorily.

2.24.2 The determination will take into account the tenderer's financial and technical capabilities. It will be based upon an examination of the documentary evidence of the tenderers qualifications submitted by the tenderer, pursuant to paragraph 2.11.2, as well as such other information as KeRRA deems necessary and appropriate

2.24.3 An affirmative determination will be a prerequisite for award of the contract to the tenderer. A negative determination will result in rejection of the Tenderer's tender, in which event KeRRA will proceed to the next highest combined score tender to make a similar determination of that Tenderer's capabilities to perform satisfactorily.

2.25 Award Criteria

2.25.1 Subject to paragraph 2.29 KeRRA will award the contract to the successful tenderer whose tender has been determined to be substantially responsive and has been determined to be the highest combined score tender, provided further that the tenderer is determined to be qualified to perform the contract satisfactorily.

2.25.2 To qualify for contract awards, the tenderer shall have the following: -

- (a) Necessary qualifications, capability experience, services, equipment and facilities to provide what is being procured.
- (b) Legal capacity to enter into a contract for procurement
- (c) Shall not be insolvent, in receivership, bankrupt or in the process of being wound up and is not the subject of legal proceedings relating to the foregoing.
- (d) Shall not be debarred from participating in public procurement.

2.26. Procuring entity's Right to accept or Reject any or all Tenders

- 2.26.1 KeRRA reserves the right to accept or reject any tender, and to annul the tendering process and reject all tenders at any time prior to contract award, without thereby incurring any liability to the affected tenderer or tenderers or any obligation to inform the affected tenderer or tenderers of the grounds for KeRRA's action. If KeRRA determines that none of the tenders is responsive, KeRRA shall notify each tenderer who submitted a tender.
- 2.26.2 KeRRA shall give prompt notice of the termination to the tenderers and on request give its reasons for termination within 14 days of receiving the request from any tenderer.
- 2.26.3 A tenderer who gives false information in the tender document about its qualification or who refuses to enter into a contract after notification of contract award shall be considered for debarment from participating in future public procurement.

2.27 Notification of Award

- 2.27.1 Prior to the expiration of the period of tender validity, KeRRA will notify the successful tenderer in writing that its tender has been accepted.
- 2.27.2 The notification of award will signify the formation of the contract subject to the signing of the contract between the tenderer and KeRRA pursuant to clause 2.9. Simultaneously the other tenderers shall be notified that their tenders were not successful.
- 2.27.3 Upon the successful Tenderer's furnishing of the performance security pursuant to paragraph 2.29 KeRRA will promptly notify each unsuccessful Tenderer and will discharge its tender security, pursuant to paragraph 2.12

2.28 Signing of Contract

- 2.28.1 At the same time as KeRRA notifies the successful tenderer that its tender has been accepted, KeRRA will simultaneously inform the other tenderers that their tenders have not been successful.
- 2.28.2 Within fourteen (14) days of receipt of the Contract Form, the successful tenderer shall sign and date the contract and return it to KeRRA.
- 2.28.3 The contract will be definitive upon its signature by the two parties.

2.28.4 The parties to the contract shall have it signed within 30 days from the date of notification of contract award unless there is an administrative review request.

2.29 Performance Security

2.29.1 The successful tenderer shall furnish the performance security in accordance with the Conditions of Contract, in a form acceptable to KeRRA.

2.29.2 Failure by the successful tenderer to comply with the requirement of paragraph 2.29 or paragraph 2.30.1 shall constitute sufficient grounds for the annulment of the award and forfeiture of the tender security, in which event KeRRA may make the award to the next highest combined score tender or call for new tenders.

2.30 Corrupt or Fraudulent Practices

2.30.1 KeRRA requires that tenderers observe the highest standard of ethics during the procurement process and execution of contracts. A tenderer shall sign a declaration that he has not and will not be involved in corrupt or fraudulent practices.

2.30.2 KeRRA will reject a proposal for award if it determines that the tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question

2.30.3 Further a tenderer who is found to have indulged in corrupt or fraudulent practices risks being debarred from participating in public Procurement in Kenya.

APPENDIX TO INSTRUCTIONS TO TENDERERS

The following information for the procurement of insurance medical services shall complement, supplement, or amend, the provisions on the instructions to tenderers. Wherever there is a conflict between the provisions of the instructions to tenderers and the provisions of the appendix, the provisions of the appendix herein shall prevail over those of the instructions to tenderers.

SECTION III: GENERAL CONDITIONS OF CONTRACT

3.1. Definitions

3.1.1 In this Contract, the following terms shall be interpreted as indicated:

- (i) “The Contract” means the agreement entered into between KeRRA and the tenderer, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- (ii) “The Contract Price” means the price payable to the tenderer under the Contract for the full and proper performance of its contractual obligations
- (iii) “The Services” means services to be provided by the tenderer including any documents, which the tenderer is required to provide to KeRRA under the Contract.
- (iv) “KeRRA” means the organization procuring the services under this Contract
- (v) “The Service provider” means the organization or firm providing the services under this Contract.
- (vi) “GCC” means the General Conditions of Contract contained in this section.
- (vii) “SCC” means the Special Conditions of Contract
- (viii) “Day” means calendar day

3.2. Application

3.2.1 These General Conditions shall apply to the extent that they are not superseded by provisions of other part of the contract

3.3. Standards

3.3.1 The services provided under this Contract shall conform to the standards mentioned in the schedule of requirements.

3.4. Use of Contract Documents and Information

3.4.1 The Service provider shall not, without KeRRA’s prior written consent, disclose the Contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of KeRRA in connection therewith, to any person other than a person employed by the service provider in the performance of the Contract.

3.4.2 The Service provider shall not, without KeRRA’s prior written consent, make use of any document or information enumerated in paragraph 3.4.1 above.

- 3.4.3 Any document, other than the Contract itself, enumerated in paragraph 3.4.1 shall remain the property of KeRRA and shall be returned (all copies) to KeRRA on completion of the contract's or performance under the Contract if so required by KeRRA.

3.5. Patent Rights

- 3.5.1 The Service provider shall indemnify KeRRA against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the services under the contract or any part thereof.

3.6 Performance Security

- 3.6.1 Within twenty-eight (28) days of receipt of the notification of Contract award, the successful tenderer shall furnish to KeRRA the performance security where applicable in the amount specified in SCC
- 3.6.2 The proceeds of the performance security shall be payable to KeRRA as compensation for any loss resulting from the Tenderer's failure to complete its obligations under the Contract.
- 3.6.3 The performance security shall be denominated in the currency of the Contract, or in a freely convertible currency acceptable to KeRRA and shall be in the form of:
- a) Cash.
 - b) A Bank guarantee.
 - c) Such insurance guarantee approved by the Authority.
 - d) Letter of credit.
- 3.6.4 The performance security will be discharged by KeRRA and returned to the Bidder not later than thirty (30) days following the date of completion of the Service provider's performance of obligations under the Contract, including any warranty obligations, under the Contract.

3.7. Delivery of services and Documents

- 3.7.1 Delivery of the services shall be made by the Service provider in accordance with the terms specified by KeRRA in the schedule of requirements and the special conditions of contract

3.8. Payment

- 3.8.1 The method and conditions of payment to be made to the service provider under this Contract shall be specified in SCC
- 3.8.2 Payment shall be made promptly by KeRRA, but in no case later than sixty (60) days after submission of an invoice or claim by the service provider.

3.9. Prices

- 391 Prices charged by the service provider for Services performed under the Contract shall not, with the exception of any price adjustments authorized in SCC vary from the prices quoted by the tenderer in its tender or in KeRRA's request for tender validity extension the case may be. No variation in or modification to the terms of the contract shall be made except by written amendments signed by the parties.
- 392 Contract price variations shall not be allowed for contracts not exceeding one year (12 months)
- 393 Where contract price variation is allowed the variation shall not exceed 10% of the original contract price
- 394 Price variation requests shall be processed by KeRRA within 30 days of receiving the request.

3.10. Assignment

- 3.10.1 The Service provider shall not assign, in whole or in part, its obligations to perform under this Contract, except with KeRRA's prior written consent.

3.11. Termination for Default

- 3.11.1 KeRRA may, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Service provider terminate this Contract in whole or in part:
- (a) if the Service provider fails to provide any or all of the services within the period(s) specified in the Contract, or within any extension thereof granted by KeRRA.
 - (b) If the Service provider fails to perform any other obligation(s) under the Contract
 - (c) If the Contract in the judgment of KeRRA has engaged in corrupt or fraudulent practices in competing for or in executing the contract
- 3.11.2 In the event KeRRA terminates the contract in whole or in part, it may procure, upon such terms and in such manner as it deems appropriate, services similar to those un- delivered and the Service provider shall be liable to KeRRA for any excess costs for such similar services. However, the service provider shall continue performance of the contract to extent not terminated.

3.12. Termination for Insolvency

- 3.12.1 KeRRA may at any time terminate the contract by giving written notice to the Service provider if the service provider becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the service provider, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to KeRRA.

3.13. Termination for Convenience

- 3.13.1 KeRRA by written notice sent to the service provider, may terminate the contract in whole or

in part, at any time for its convenience. The notice of termination shall specify that the termination is for the procuring entities convenience, the extent to which performance of the service provider of the contract is terminated and the date on which such termination becomes effective.

- 3.132 For the remaining part of the contract after termination KeRRA may elect to cancel the services and pay to the service provider an agreed amount for partially completed services.

3.14 Resolution of Disputes

- 3.14.1 KeRRA and the service provider shall make every effort to resolve amicably by direct informal negotiations and disagreement or disputes arising between them under or in connection with the contract
- 3.14.2 If after thirty (30) days from the commencement of such informal negotiations both parties have been unable to resolve amicably a contract dispute either party may require that the dispute be referred for resolution to the formal mechanisms specified in the SCC.

3.15. Governing Language

- 3.15.1 The contract shall be written in the English language. All correspondence and other documents pertaining to the contract, which are exchanged by the parties, shall be written in the same language.

3.16. Applicable Law

- 3.16.1 The contract shall be interpreted in accordance with the laws of Kenya unless otherwise expressly specified in the SCC.

3.17 Force Majeure

- 3.17.1 The Service provider shall not be liable for forfeiture of its performance security, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

3.18 Notices

- 3.1.1 Any notices given by one party to the other pursuant to this contract shall be sent to the other party by post or by Fax or Email and confirmed in writing to the other party's address specified in the SCC.

SECTION V - SCHEDULE OF REQUIREMENTS

TENDER FOR PROVISION OF MEDICAL INSURANCE SERVICES

1.0 Background.

Kenya Rural Roads Authority (KeRRA) was set up under the Kenya Roads Act, 2007 and charged with the mandate to construct, maintain, and rehabilitate, rural roads and is an equal opportunity employer.

The management of KeRRA is vested with the Board of Directors which consists of: The Chairman, Principal Secretary Ministry of Transport, Infrastructure, Housing & Urban Development, the Principal Secretary Treasury, the Principal Secretary Ministry of Devolution and Planning, The Director General, and 2 other persons not being public officers, appointed by virtue of their knowledge or experience in industry. The Director General is the Chief Executive Officer. Under him is a team of professionals in the fields of Civil Engineering, Survey, Human Resource Management, Finance, Auditing, Law, Procurement, ICT among others.

The Authority is managed by a Board of Directors under the leadership of a non-executive Chairman and eight (8) other members. The Director General is an ex-officio member of the Board. An analysis of the mandate of the Authority shows that the function of KeRRA falls into two (2) broad categories namely:

- a) Technical Services; and
- b) Corporate Services.

KeRRA is organized into the Office of the Director General, six (6) Directorates and two (2) stand-alone Departments as follows: -

- (i) Directorate of Planning, Design & Environmental Interests;
- (ii) Directorate of Construction;
- (iii) Directorate of Road Asset Management;
- (iv) Directorate of Policy, Strategy & Compliance;
- (v) Directorate of Corporate Services;
- (vi) Directorate of Audit Services.

The stand-alone Departments include:

- (vii) Corporation Secretary & Legal Services; and
- (viii) Supply Chain Management Department

The Authority's structure is further devolved into 47 (forty-seven) Regions where staff are also present.

The current staff capacity is Six Hundred and Seventy (630) employees. Directors are also covered under the scheme. There are two (2) directors covered under the medical scheme. KeRRA has set aside funds for the provision of medical services for its staff, spouses and their

dependants during the financial year 2018/2019. The funds are intended to finance in-patient and out-patient medical services.

The selected medical provider(s) shall ensure that controls and procedures are not unnecessarily bureaucratic and cumbersome. The information to be provided by tenderers shall be detailed and correct to the best of tenderers knowledge and any misrepresentation shall render the tender non-responsive.

The successful service provider will be awarded a two (2) year contract renewable annually at the sole discretion of Kenya Rural Roads Authority. The scope of service as follows;

2.0 Medical Services

2.1 Inpatient Scheme

The inpatient scheme deals with illness or accidents that will lead to:

- (a) admission to hospital;
- (b) treatment while in hospital; and
- (c) Discharge from hospital and the cost of treatment thereof.

2.2 Out-patient Scheme

The Outpatient scheme deals with cases of illness and accidents not requiring admission into a hospital. Under this scheme, beneficiaries require examinations, diagnosis and speedy treatment at health clinics, hospitals, etc., with the aim of preventing any ailment or illness from growing into cases requiring hospitalization.

2.3 Additional Information

2.3.1 Particulars of cover

The medical cover exclusions, where applicable, **MUST** be clearly stated on a separate cover giving specific details on each exclusion.

One must also provide: -

- 1. Full details of what the cover provides
- 2. Eligible expenses included in the in-patient cover
- 3. Full details of what the cover excludes
- 4. Dependents' eligibility (Children 0-18 years or up to twenty-five (25) years if in school and Member up to sixty (60) years of age).

2.3.2 Network coverage

The bidder is required to provide the following: -

- 1. Full details of towns where the medical provider or Insurance Company is represented.
- 2. Full details of the medical cover outside Kenya and all exclusions that are applicable.

This is taking into consideration that Kenya Rural Roads Authority employees are situated all over the country and also the facts that;

- a) The Employee's do not necessarily stay with their family members; some may be staying up country in their rural homes, and that
- b) KeRRA members of staff frequently travel out of the country on official duties.

2.3.4 Preparation of Your Proposal

1. Give a detailed report on how the cover is going to be administered,
2. Give an analysis on how the service provider intends to address the following issues/procedures: -
 - a) Admission of members into the cover,
 - b) Admission of members with pre-existing conditions into the cover.
Members to be covered fully in in-patient limit with no sub-limits.
 - c) Admission of HIV/AIDS related cases to the cover to be covered fully with no sub-limits,
 - d) Procedure to be followed for overseas cover,
 - e) Procedure to be followed to procure last expense (if any in your package)

4.0 COMPLIANCE WITH SCOPE OF SERVICES

- a) The Insurance recommend only one underwriter, where quotations from more than one recommended underwriter are provided. The Company shall be entitled to reject the brokers bid for the respective policy as non-responsive.
- b) The price schedule for the policy shall be supported by AKI recommended original price quotations from the recommended underwriter signed by the authorized Official.
- c) The Brokers shall state the AKI recommended rates used to determine the premium used to arrive at the prices indicated for each policy. Declaration rates shall also be stated on the declaration based policies.
- d) For the purpose of payment of premium by The Company, brokers shall indicate separate premium quotations for each of the two periods of insurance. The premium shall be as quoted and subsequently awarded for the full two-year term.
- e) Prices indicated on the price schedule shall be the total cost of the services quoted including premium, deductible, brokerage remuneration, all customs due and other taxes.
- f) Unit prices and rates quoted and indicated by the broker shall be fixed during the term of contract. A tender submitted with an adjustable price quotation will be rejected.
- g) The broker shall complete the appropriate price schedule indicating the policies quoted for the premium including applicable taxes, duties, levies, brokerage remuneration and excess limits.

- i) The Company shall take into consideration previous past claims and underwriting performance of underwriters in determining the substantial responsiveness at tender award. The factors to be considered shall include arbitrary rejection of disputed claims and failures to satisfactory conclude claims and satisfy agreed performance benchmarks.
- j) The broker shall ensure that the recommended underwriter has the capacity to underwrite a minimum lead of 30% of the policy awarded on asset based policies.
- k) The Employer shall further negotiate with the successful bidder prior to drawing up of the final contract.
