TO TENDERERS

2. Bidders are to attach copies of the mandatory requirements i.e. Certified copies of Certificate of incorporation, National Construction Authority Certificate category 4, 5,6,7.
3. PIN registration certificate with VAT registration obligations, copy of valid tax compliance certificate and other documents specified in the bid document.
4. For the Tenders under special group the bidders must be registered under the public and asset disposal act (preference and reservations) regulations, 2015 and provide documents from treasury to prove that they belong to any of the above category.
5. Bidders may be required to provide the original mandatory documents before the award.
6. In addition, the Bidders shall provide all information and documents required by the Employer in bid document.
