PIN registration certificate with VAT registration obligations, copy of valid tax compliance certificate and other documents specified in the bid document.

Provide (*where applicable*) valid certified certificate of registration with National Treasury for Access to Government Procurement Opportunities (AGPO) in the relevant group (Women, Youth or Persons Living with Disability)-for PWD bidders should provide evidence of director's registration with the National Council of People Living with Disability
4. Bidders may be required to provide the original mandatory documents before the award.
5. **In addition, the Binders shall provide all information and documents required by the Employer in bid document.**
