9. Bidders should have their documents paginated (serialized) to ensure compliance with section 74 (1) (i) of the Public Procurement and Asset Disposal Act, 2015. This should be in the format 1,2,3,4,5 from the First Page up to Last Page).
10. Opening of the bids will take place immediately thereafter at the respective addresses **in the presence of the tenderers or their representatives who choose to attend.**
11. Bids not received at the submission venue by the closing date and time will not be accepted for opening and will be rejected and returned unopened.
